THE COUNCIL OF MINISTERS OF THE REPUBLIC OF POLAND ISSUED A REGULATION FOR THE PROTECTION OF PUBLIC HEALTH AND THE LIMITATION OF THE COVID-19 SPREAD (SARS-COV-2) WHICH INTRODUCES BANS IN AIR TRAFFIC.

II.

THE REPUBLIC OF POLAND RESTORED BORDER CONTROL AT THE NIGHT OF MARCH 13/14 2020.

III.

FROM MARCH 15, 2020, AT 0000LMT (MARCH 14, 2020, AT 2300UTC) TILL MARCH 28, 2020, AT 2359LMT (MARCH 28, 2020, AT 2259UTC) CIVIL AIRCRAFT PERFORMING INTERNATIONAL FLIGHTS WITH PASSENGERS, EXCLUSIVE OF FLIGHTS INDICATED IN POINT IV, ARE BANNED FROM LANDING ON AIRPORTS ENTERED INTO THE REGISTER OF CIVIL AIRPORTS AND ON AIRSTRIPS ON THE LIST OF THE REPUBLIC OF POLAND'S AIRSTRIPS.

IV.

THE BAN MENTIONED IN POINT III DOES NOT CONCERN: CARGO FLIGHTS, FLIGHTS WITHOUT CARGO AND WITHOUT PASSENGERS AND:

1) FLIGHTS WITH STATUS: HOSP, HUM, HEAD AND OTHER FLIGHTS PERFORMED IN ORDER TO SAVE PEOPLE'S LIVES OR HEALTH (E.G. WITH THE 'RESCUE' PAROLE), FLIGHTS TO PROTECT PUBLIC ORDER (E.G. WITH THE 'GUARD' PAROLE),

2) FLIGHTS WITH THE FOLLOWING PERSONS RETURNING TO THE REPUBLIC OF POLAND BY AIRCRAFT CHARTERED AT THE ORDER OF TOUR OPERATORS OR AN ENTITY ACTING ON THEIR BEHALF BEFORE MARCH 15, 2020 OR AT THE ORDER OF THE PRIME MINISTER:

- CITIZENS OF THE REPUBLIC OF POLAND,
- FOREIGNERS WHO ARE SPOUSES OR CHILDREN OF CITIZENS OF THE REPUBLIC OF POLAND OR WHO ARE UNDER PERMANENT CUSTODY OF CITIZENS OF THE REPUBLIC OF POLAND,
- FOREIGNERS HAVING A POLE'S CARD,
- HEADS OF DIPLOMATIC MISSIONS AND MEMBERS OF THE DIPLOMATIC AND CONSULAR PERSONNEL OF A MISSION, I.E. PERSONS WITH A DIPLOMATIC RANK AND MEMBERS OF THEIR FAMILIES,
- FOREIGNERS WITH A PERMANENT OR TEMPORARY RESIDENCE PERMIT ON THE TERRITORY OF THE REPUBLIC OF POLAND,
- FOREIGNERS WITH A RIGHT TO BE EMPLOYED ON THE TERRITORY OF THE REPUBLIC OF POLAND, I.E. FOREIGNERS WITH A RIGHT TO PERFORM WORK ON THE SAME RULES AS CITIZENS OF THE REPUBLIC OF POLAND, HAVING AN EMPLOYMENT PERMIT, A SEASONAL EMPLOYMENT PERMIT, A STATEMENT ON ENTRUSTMENT OF WORK TO A FOREIGNER ON THE TERRITORY OF THE REPUBLIC OF POLAND,
- FOREIGNERS WHO GAINED A PERMIT OF THE COMMANDER OF A BORDER GUARD UNIT TO ENTER THE TERRITORY OF THE REPUBLIC OF POLAND,

3) CHARTER FLIGHTS PERFORMED BY FOREIGN AIR CARRIERS WHICH WILL BE PERFORMED AT THE ORDER OF FOREIGN STATES IN ORDER TO BRING BACK THEIR CITIZENS,

4) EMERGENCY FLIGHTS.

V.

BEFORE THE TAKE-OFF, AIR OPERATORS ARE OBLIGED TO INFORM THE PASSENGERS WHO FLY TO THE REPUBLIC OF POLAND ABOUT THE CONTENTS OF POINT III AND IV ABOVE.

VI.

AIR OPERATORS WHOSE AIRCRAFT PERFORM TRANSIT FLIGHTS THROUGH THE EPWW FIR, SHOULD NOT PLAN ALTERNATE AIRPORTS ON THE TERRITORY OF THE REPUBLIC OF POLAND.

VII. FROM MARCH 16, 2020 AT 00:00LMT (MARCH 15, 2020 AT 2300UTC) TILL MARCH 28, 2020 AT 23.59LMT (MARCH 28, 2020 AT 2259UTC) COMMERCIAL FLIGHTS WITH PASSENGERS WITHIN THE REPUBLIC OF POLAND ARE BANNED EXCEPT FOR FLIGHTS CARRIED OUT BY PUBLIC OR STATE INTEREST.
